

Faculty of Medicine and Health Sciences – Assistant Professor (Clinical)/Associate Professor (Clinical), Department of medicine, Division of Oncology and CIUSSS - ODIM

Position Description

The Division of Hematology and Medical Oncology of the Centre Intégré Universitaire de Santé et de Services Sociaux Ouest-de-l'île-de-Montréal (CIUSSS ODIM), a McGill University academic affiliate and the Department of Oncology of McGill University, invite applications for a position as Assistant or Associate Professor, full-time clinical academic track, in Oncology. This position (PEM) will be held at the Lakeshore General Hospital (LGH), but is a CIUSSS position and accordingly, the candidate will also be assigned to St Mary's Hospital, as per operational requirements. This position is to be filled, effective, after July1st, 2024. This position does not confer eligibility for tenure.

The Lakeshore General Hospital (LGH) is a founding member of the CIUSSS ODIM. Members of the division will have a principal appointment at the Lakeshore General Hospital but are also appointed as Associate Attending at St Mary's Hospital, and LaSalle Hospital, the other major hospitals in the CIUSSS. Together, these constitute over 500 inpatient beds and provide care to approximately 650,000 people. This position will be held within the Department of Oncology, McGill University, with an associate appointment in the Department of Medicine of McGill University.

Job Duties

Clinical responsibilities will include outpatient clinical practice in hospital-based clinics, malignant solid tumour diseases, and inpatient and outpatient consultation in medical oncology and hematology. These activities may be at either of the main hospital sites, or both.

The candidate should be able to provide documentation of expertise in fields such as clinical trials and translational research.

The candidate should have expertise in the holistic management of solid tumour oncology, and be comfortable with common benign hematology cases.

The candidate will actively engage in and encourage scholarly activity, to enhance the academic environment of the division. This will require the ability to bridge multiple areas of clinical practice and research.

A demonstrated ability to work in multidisciplinary teams that include research and clinical staff is essential. The position will require the supervision of trainees at all levels, as well as participation in the professional and academic activities of the division. The candidate is expected to be actively involved in all aspects of McGill's academic mission (teaching and supervision of clinical trainees, pursuit of research and involvement in academic and hospital committees).

McGill faculty members are expected to contribute to service activities within their units, the University, and the wider scholarly community. A demonstrated commitment to equity, diversity, and inclusion is also expected.

Qualifications and Education Requirements

- The candidate must hold an MD degree and have completed sub-specialty training in Internal Medicine and Medical Oncology, and have completed additional training post-residency or have commensurate experience, in an academic environment.
- Candidates must be certified by the Royal College of Physicians and Surgeons of Canada (or equivalent); and be eligible for licensure in Quebec and certification by the "Collège des Médecins du Québec"
- The candidate must be Royal College certified.
- All candidates must be fluent in English with a working knowledge of French, and must be able to complete the French-language proficiency exam (if applicable). The candidate must be eligible for licensure in Québec and certification by the "Collège des Médecins du Québec".
